

CEMETERY COMMITTEE

The St. Grégoire Cemetery Committee held its first meeting on Friday, February 10th. The committee is comprised of representatives from St. Luc, St. Grégoire and Our Lady of Victory (Susan Lemieux) parishes. The Committee's mandate is to recommend to the St. Grégoire wardens strategies to manage the financing and upkeep of the cemetery.

At present, the Committee is focused on searching for family representatives for plots not claimed. It was pointed out at the meeting that grave sites are not owned by the families but are leased and each lease has a termination date. This is why each plot needs to have a contact person. While the Committee has no immediate plan to reclaim leases which have terminated, there is always a possibility that in the future, the Committee could recommend this approach to the Fabrique.

If the Fabrique were to agree to the reclaiming of grave sites, they would have to do the following: undertake a detailed search for family representatives. If no one comes forth, three public announcements must then be made identifying the family and grave site in question. If still no one comes forward, a recommendation for resale is forwarded to the Diocese for their approval. As stated earlier, there is no immediate need to reclaim grave sites as the graveyard still has room to expand.

Committee members were advised that cemetery plots can be transferred to not only direct family members, but also to other relatives as well. The new owners of the plot would then be responsible for costs and maintenance.

The Committee is also looking at creative ways to raise funds to support the cemetery. One idea under study is to investigate the possibility of seeking government funding to preserve certain grave sites because of their historical importance. Another possibility is to create a website to better communicate to the general public the challenges of managing a cemetery where churches no longer have access to large amounts of funding.

ASH WEDNESDAY - OUR MOUNTAIN CLIMBING TOWARDS EASTER BEGINS

This coming Tuesday, February 21st, our church will look a little different; it will have a Lenten look – *the cross, the ashes, the banners, the purples*. They underline the fact that as Christians we are signing up for renewal on the way to Easter when we will have our baptism renewed. The scripture readings and the music will sound different too as part of the Lenten repertoire.

On Tuesday evening at 7:00 pm, there will be a service at OLV in which we receive the ashes. The receiving of the ashes is a sign that we are serious about the upcoming season of renewal and conversion.

However, let us not loose sight of Easter. We do not observe Lent for its own sake. It is meant to get us in shape to celebrate the central mystery of our faith: *The death and resurrection of Jesus Christ*. That core mystery will be celebrated right after Lent during the Three Great Days of Holy Thursday evening, Good Friday, Easter Saturday/Easter Sunday.

On Ash Wednesday, we start our 40-day trek to Easter. We can mark the journey with the traditional Lenten practices of prayer, fasting and almsgiving.

Prayer	Our Sunday liturgies, with their rich Bible readings, provide the basic orientation for Lent. How about making a special effort to use the FOOD FOR THE WEEK item found on the front cover of the bulletin? You can also take a copy of the Lent 2012 Daily Reflections, Activities, and Prayers booklet "Becoming Healers for Jesus" which were purchased by the Liturgy Committee. There are only a few copies for each parish – first come, first served.

Fasting	During Lent, we could refrain from some food, from a drink, from a party, from a video as a gesture of solidarity with those who have no choice in these matters, for the simple reason that they do not have them. This sort
	of fasting can also be done to show that we can distance ourselves from so much of what our consumer society says we need.
Alms	This flows naturally from the previous two practices. Alms-giving says we care for others, even to the point of depriving ourselves from something. How about making the money we save this way into our contribution to the special <i>Development and Peace</i> Share Lent collection that will be held later on in Lent?



We pray that this 40-day Lenten period may be grace-filled for our parish, for ourselves; that it will prepare us well for the upcoming feast of Easter.

The Share Lent campaign of **Development and Peace** begins with Ash Wednesday, February 22nd. Inserted with the bulletin this weekend is a Solidarity Calendar.
